## **Approve Treas. Report January**

- Treasurer reports for Jan 2023, Feb 2023, and March 2023 will be approved in April due to Budget not being approved as of yet for appropriation.
- Morrow County Budget Commission will need to Approve Budget received, need resolution for Council to approve the appropriation for the approved budget to be uploaded into the system.
  - Once approved will have January, February and most likely March Bank Reconciliations to be approved in April.
  - Question is there anything we need to look at from the bank statements?
     Answer Everything that has been spent to date has either been budgeted or has a Resolution with council approval if it was not a budgeted expense.

## **Old Business:**

- Storm Drains Mayor Paula Bowman and Pamela Porter met with 3 contractors Gage Goodman, Randy Buecher and Avery Nauman to review the drains from Patrick Brackens building to Patty Roberts building.
  - Inspected the area, noticed that the downspouts are draining down into the building.
  - All agreed to put a section of pipe in front of Patty's building all the way over to Pat's building and tap into the catch basin

- Drains are 39" Long with a 19 1/2" grate, it will be 2 grates per trench drain. The trench will be about a 1' to 1 1/2'.
- All 3 stated that they would use piping
- o ODOT has 224 Trench Drains (about 211 feet) with Grates
- 2 of the contractors recommended using the Black pipes
- 1 contractor recommends using the Blue pipes.
- Will need to get Estimates and bring to the council
- Stop signs
  - Need to take down the one on NORTH and SHORT and put back as a Yield
  - Need new posts with bolts will need to order
  - What Street Signs are needed? Need Mound / Sandusky
- Bob Thomas would like Chesterville Village to take over the Roads in Chester Estates
  - Still need to ensure that street lights and curbs are put in
  - Need to have Bob provide the agreement
  - Look at the court house for documentation
  - Dixie Shinaberry for documentation as to what was agree'd upon.
- Kitchen ceiling /floor
  - Kitchen ceiling was completed but need to get the floor upgraded
- Mike Follen
  - Mayor would like to pay Mike Follen for his services of Snow removal
  - Need Mike to submit an invoice to the Village for services
- Lien for non-payment of Trash
  - Mayor would like to place a lien on 40 Portland due to non-payment for Trash Services of \$321.30 in arrears. Also, would like to place on 60 Portland for non-payment of \$32.00 in Arrears.
    - O This is the 2<sup>nd</sup> time these 2 properties have been discussed for non-payment
  - The smaller amount would recommend to send certified letter to discuss the arrears
  - Beverly Moser motioned to approve a resolution to put in a lien for Trash Collection for 40 Portland Street – Seconded by Jason Coey.
