- Zoning Inspector:
  - How would we pay? Suggest using 50% of the fee's collected
  - o Question Why would we not just use Morrow County Inspector
    - Morrow County zoning is at the county level and they will not go to the village level of Zoning.
      - If someone builds would they have to pay for both Morrow County and Village? No Permits would be at the village level.
  - Recommend
    - Build a Planning Commission first
      - Eligible Members (5 in total)
        - Mayor, 1 Council and 3 members of the village
    - Appeals committee

- Eligible Members (5 in total)
  - 2 Council Members and 3 members of the village
- Both will meet at their digression
  - Must follow the Sunshine meeting Law
- Will need someone to document minutes and appoint Chair and Vice Chair for both
- Ensure to get communications out to village
- Develop communication for planning group
- Beverly Moser would be Press relations
- Blyth Letters
  - Council would rather get someone knocking on the door vs receiving a Nasty Certified Letter.
- Are we maintaining the Zoning Code and what functions would the council like to see the Zoning Inspector perform?
  - Write up citation and enforce the zoning policies.
- If you know volunteers who would like to be part of the Zoning committee please have them reach out to the Mayor.
- There is no Budget for this year so the position would be without payment – volunteer zoning Inspector.
